

## Kindergarten—8th Grade Scholarship & Grant

Concordia Lutheran School and its supporting congregation, Concordia Lutheran Church are committed to making every effort to provide Christian education to every family that desires it. Since the entire cost of tuition may be difficult for some families to afford, Concordia offers assistance for qualifying families.

- All families are expected to pay the full Enrollment Fee, as well as a portion of the tuition.
- Only one scholarship form needs to be completed per family.
- All fees must be paid and balances cleared in order to be considered for any of the available scholarships.

### Kindergarten - 8th Grade Scholarship Opportunities

#### 1. Indiana School Choice (State Vouchers)

Concordia Lutheran School is a participant in the State of Indiana School Choice Scholarship program. Guidelines and eligibility are determined by the State of Indiana, and are based upon family income levels and family size. All families are encouraged to apply for this scholarship, as nearly all families will qualify. Each family will receive the appropriate scholarship application and guidelines upon enrollment.

#### 2) Concordia Support Grant

Families that do not qualify for the Indiana Choice Scholarship may apply for the Concordia Support Grant. Those forms are available through the school office and are provided upon request or as the need arises.

## Preschool Scholarship

### Preschool Scholarship Opportunities

#### 1) SGO Scholarship

Families enrolling students in 4-year-old (4 by 8/1/24) or 5-year-old preschool who would like to be considered for financial assistance may do so by completing an SGO Application Form along with providing a brief explanation of the reasoning for the request. Forms are available upon request through the school office. Each year there will be a predetermined amount of scholarship funds made available. Scholarship forms are due by June 30 each year and awards will be given in the month of July. Award amounts are determined by need, number of requests, and the amount available for disbursement.

### 2024-2025 Tuition/Enrollment Fees

**\*Enrollment Fee must be paid at time of enrollment to hold a place in the class. Enrollment Fee is non-refundable.**

### Payment Options

Your choice of payment is determined when you sign a tuition contract. Existing tuition contracts are not automatically renewed. A new tuition contract must be signed at the beginning of each school year. Certain fees are due at enrollment, and are not eligible for a payment plan. In the event that any payment is returned for NSF, CLS will charge you a \$25 fee.

#### Method of Payment:

Payments may be paid with cash, check or money order or via FDPay (Fast Direct).

Pay In Full Option: (1 payment)  
Pay balance in **full** on or before August 5, 2024.

Semester Payment Option: (2 payments)  
This option allows you to split your tuition into 2 payments. 1st half payment is due on or before August 5, 2024, and 2nd half payment due on or before January 6, 2025.

Monthly Payment Option:  
Funds are automatically withdrawn from your bank account via FDPay. We have two 10 month plans in place (August-May) or (Sept-June). Payments will need to be setup in Fast Direct to process monthly.

### School/Enrollment Fees

These fees are not included in tuition cost and do not qualify under any scholarships.

- **Enrollment Fee**– Preschool-8th = \$170
- **Band/Strings**-(See Band/Strings Form on website under [Programs](#) tab) for program cost
- **Athletic Fees**-Differs with each sport.
- **Lunch**– Lunches are available for purchase. (free and reduced lunches are offered to qualifying families)
- **Extended Care**– \$1.75 per child per 1/2 hour with a \$25 registration fee

### Tuition Policy

At Concordia Lutheran School we seek to continually evaluate our programs in order to provide the best in Christian education utilizing all available resources. This includes, but is not limited to, our fiscal responsibility. We seek to maximize existing potential sources of income which can be utilized to benefit our school and improve upon the already high quality product. In light of this process, the School Board of Concordia Lutheran School has approved the following tuition policy to become effective for the 2024-2025 school year.

To attend CLS, a student's parent(s) or guardian(s) must sign a tuition contract that specifies the payment option and personal responsibilities.

1. All tuition and outstanding obligations from any preceding year must be paid in full before a student will be allowed to register for the next school year. All fees must be paid prior to any scholarship applications.
2. Students withdrawing from school during a given month will be charged the full month's tuition.
3. When a student withdraws, the adjusted balance of tuition and fees will be used to determine the final amount or credit due.
4. Financial resources are applied to tuition in the following order.  
\*Choice (State Voucher) Scholarship (K-8th)  
\*Support Grant (K-8th)  
\*SGO Scholarship (PK, 4 & 5 yrs. by 8/1/24)
5. Scholarships awarded to students by CLS vary according to the family's financial need. CLS reserves the right to revise scholarships should the family's financial circumstances change and/or other resources become available to the family.
