

Scholarships

Prior to applying for any possible scholarships, all school fees **MUST** be paid in full. All families are encouraged, but not required to apply for one or more of the scholarships offered by Concordia Lutheran School. These scholarships will be applied in the order identified within this policy provided the eligibility components have been met. Students **MAY** qualify for more than one scholarship. Families **MUST** apply for scholarships in order to receive an award. In some cases a family may be eligible for multiple awards or no award. Applications will be included in registration materials and will be made available upon request and on the school website. Scholarships are only available for students in K-8th grade.

Choice Scholarship (provided via the State of Indiana) - Eligibility is determined by guidelines as determined by the State of Indiana. Qualifying income levels will be made available once they have been provided to Concordia. A current 1040 tax form and documentation of any additional income you may receive is required.

Scholarship Granting Organization (SGO) - Eligibility is determined by income level equal to 200% of the Free and Reduced lunch income levels provided by the State of Indiana. These amounts will be available once they have been provided to Concordia. A current 1040 tax form, or other income verification is required along with the SGO application

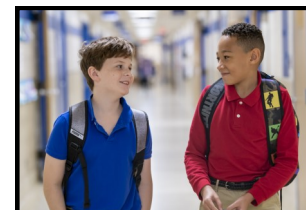
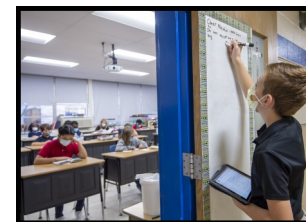
Grant

Thank you for your interest in Concordia Lutheran School. The following information is provided about our tuition and fees.

2023– 2024 Tuition/Enrollment Fees

***Enrollment Fee must be paid at time of enrollment to hold a place in the class. Enrollment Fee is non-refundable.**

Payment Options

Your choice of payment is determined when you sign a tuition contract. Existing tuition contracts are not automatically renewed. A new tuition contract must be signed at the beginning of each school year. Certain fees are due at enrollment, and are not eligible for a payment plan. In the event that any payment is returned for NSF, CLS will charge you a \$25 fee.

Method of Payment:

Payments may be paid with cash, check or money order or via FDPay (Fast Direct).

Pay In Full Option: (1 payment)
Pay balance in full on or before August 7, 2023.

Semester Payment Option: (2 payments)
This option allows you to split your tuition into 2 payments. 1st half payment is due on or before August 7, 2023, and 2nd half payment due on or before January 3, 2024.

Monthly Payment Option:
Funds are automatically withdrawn from your bank account via FDPay. We have two 10 month plans in place (August-May) or (Sept-June). Payments will need to be setup in Fast Direct to process monthly.

School/Enrollment Fees

These fees are not included in tuition cost and do not qualify under any scholarships. Fees MUST be paid before any scholarship applications will be processed.

- **Enrollment Fee**– K-8= \$160 : Preschool= \$140
- **PTL fee (annual)**- \$10/family plus \$5/enrolled student.
- **Milk Fee Annual -Preschool only)-** \$60
- **Band/Strings**-(See Band/Strings Form on website under [Programs](#) tab) for program cost
- **Athletic Fees**-Differs with each sport.
- **Lunch**– Lunches are available for purchase. (free and reduced lunches are offered to qualifying families)
- **Extended Care**– \$1.75 per child per 1/2 hour with a \$25 registration fee

Tuition Policy

At Concordia Lutheran School we seek to continually evaluate our programs in order to provide the best in Christian education utilizing all available resources. This includes, but is not limited to, our fiscal responsibility. We seek to maximize existing potential sources of income which can be utilized to benefit our school and improve upon the already high quality product. In light of this process, the School Board of Concordia Lutheran School has approved the following tuition policy to become effective for the 2023-24 school year.

To attend CLS, a student's parent(s) or guardian(s) must sign a tuition contract that specifies the payment option and personal responsibilities.

1. All tuition and outstanding obligations from any preceding year must be paid in full before a student will be allowed to register for the next school year. All fees must be paid prior to any scholarship applications.
2. Students withdrawing from school during a given month will be charged the full month's tuition.
3. When a student withdraws, the adjusted balance of tuition and fees will be used to determine the final amount or credit due.
4. Financial resources are applied to tuition in the following order.
*Choice Scholarship
*SGO Scholarship
*Support Grant
5. Scholarships awarded to students by CLS vary according to the family's financial need. CLS reserves the right to revise scholarships should the family's financial circumstances change and/or other resources become available to the family.
