Prior to applying for any and all possible scholarships, the per student base tuition rate for Concordia Students for the 2022-2023 school year will be \$6,000.00 for grades 1-8 and \$4,000.00 for Kindergarten. All Families are encouraged, but not required to apply for one or more of the scholarships offered by Concordia Lutheran School. These scholarships will be applied in the order identified within this policy, provided the eligibility components have been met. Students MAY qualify for more than one scholarship.

The scholarships offered are as follows and will be applied in the order in which they are presented. Please check the box of any or all scholarships you wish to apply for. Please fill out the required paperwork and/or questions for each scholarship you wish to apply for. Scholarships are available to students in Kindergarten to 8th Grade.

Choice Scholarship- Eligibility is determined by guidelines determined by the State of Indiana. Qualifying income levels will be made available once they have been provided to Concordia. Additional forms will need filled out at a later date for this scholarship.

Required paperwork for a choice scholarship-

- Income Assurance form
- Household Size Assurance Form
- 1040 Tax Form (2021 must include all dependents listed and your adjusted gross income)
- Additional forms for income or household size changes on your tax form (not required by everyone)

Required forms:

- SGO Application
- 1040 Tax Form (2021 must include all dependents listed and your adjusted gross income)

□ Support Grant: This is a financial support grant. This option is utilized when other scholarship opportunities do not apply or are insufficient. Amounts will be determined through an application. The principal and School Board will meet and determine approval based upon available tuition assistance funds. This grant is open to members and non-members.
